## **Terms and conditions**

The General Terms of Use given here are considered and accepted by the very act of access and use of the internet portal "esi.mk", which includes all their changes and additions, unless otherwise stated.

The general conditions and their future changes and additions are valid from the day of setting up the website and are automatically considered as an integral part of any and any agreement in any form concluded between any natural person and / or legal entity users of the portal.

Registered employers can at any time post job advertisements and use the services of the experts from the Agency in relation to the published advertisements, have access to the statistics of the attendance of the published advertisements, search CVs and use all advanced functions that are installed or will be installed, with or without compensation, depending on the package of services that will be selected.

The service for publishing vacancies is charged according to the Price List.

The Agency assumes no responsibility for any and any effect that the content of the advertisement may have on any person or the general public. However, at its own discretion, the Agency may delete texts that it deems offensive, discriminatory, inappropriate or content contrary to mandatory regulations and morals, but assumes no responsibility for text control.

The Agency publishes the texts of the advertisements in its entirety and is not responsible for spelling mistakes or other errors in the advertisement.

## 4. Limitation of liability

The Agency will not be held responsible for the accuracy and truthfulness of the information posted by any user of the Portal and this applies to any and all information submitted and posted by any user.
